Superintendent's Report:

The second Positive Behavior Intervention System (PBIS) training for elementary and middle level teachers, administrators and counseling staff was held last week and went very well. This initiative is part of the Social/Emotional component of the current Strategic Plan. There is one more day of training and the group will also meet during the summer to discuss roll-out of this important initiative.

Mrs. Clarke will be sending a letter home to parents regarding a Netflix television series based on Jay Asher's 2007 book entitled *Thirteen Reasons Why*. The letter was drafted by the Counseling Department in light of the large amount of students who have been viewing the

School Choice numbers have decreased from 52-47, however those 5 students have become town residents and are enrolled as such. There are 7 accepted students and 3 student applications are pending for the 2017-2018 school year.

Mrs. Clarke reported that the Administrative Leadership Team has been busy getting ready for the upcoming school year. Schedules are being reviewed as well as the possibility of select Grade 8 students taking math courses at the high school.

Mrs. Clarke met with representatives of COP sync 911, a real-time security program that would enhance the A. L. I. C. E. protocol in place in the district. She distributed an informational sheet from the company and is waiting on a quote from them.

Business and Facilities:

Mr. Smith reported that he is waiting for the final report and figures for the recently completed structural study at Quarry Hill Community School. The pool has been filled again and added, as notes for the town, that cracks were found at the bottom and will have to be eventually repaired in the future. The roof at QHCS has undergone repair over the past two weeks. There were over 100 holes and patches at the seams. A component of the structural study for QHCS is that the building needs to be made waterproof, starting with the foundation, which cannot be repaired until the drainage and gutters are fixed which in turn is contingent upon the roof being repaired and replaced having an estimated cost of approximately \$2,000,000. Mr. Smith stated that capital funding would be required for these repairs. A Facilities and Long-Term Planning subcommittee meeting will be scheduled to discuss the matters.
